**Unfinished Business:**

**A. Update on Ordinance Revisions – Village Manager Coy**

Village Manager Coy updated Council on proposed ordinance revisions. Both he and the Village attorney, Michael Gildner, are unable to locate an ordinance that permits a particular number of abandoned vehicles allowed for a specific parcel. President Quisenberry requested clarification on procedure required to revise an ordinance. Village Manager Coy will find out if a resolution, public hearing or a motion will is required. Village Manager Coy also advised Council that Mr. Gildner is willing to attend a meeting to discuss the advantages and disadvantages of changing ordinance violations to civil infraction. Council requested a written explanation from the attorney instead of meeting attendance, at this time.

**New Business:**

**A. Waste Water Committee – Village Manager Coy**

Village Manager Coy advised Council that he has met with the Township Supervisor, Kathy Thurman, regarding this issue. It was decided that a committee of Village representatives, Township representatives, business owners and residents should meet for preliminary discussions on moving forward with waste water treatment. Discussion occurred over the purpose of the committee. Timing, associated cost and past efforts were brought up. Trustee Green noted her disagreement with any attempt to move forward with this issue due to the current economic situation. Trustee Kassuba expressed concern over cost to taxpayers to form a committee, as it has been attempted in the past. Village Manager Coy assured Council that a budget for the committee is not being requested, at this time. Trustee Eschmann volunteered, along with Village Manager Coy, to represent the Village. Council will be updated on committee discussions.

**Motion by Trustee Champion**, seconded by Trustee Nivelt, to form a committee for waste water treatment with Brandon Township. Village Manager Coy & Trustee Eschmann will represent the Village.

**Motion passed with a 5 to 1 vote.**

**Items from Trustees:**

**Trustee Champion** questioned snow plowing on South Street.

**Trustee Kassuba** suggested changing the ordinance as it pertains to sidewalk snow removal. She recommended making the business and homeowners solely responsible and fining anyone who moves it into the road.

**Motion by Trustee Green**, seconded by Trustee Eschmann, to adjourn the Open portion of the Village Council meeting and move to a Closed session.
